## **Policies**

- Private lessons are \$50+HST, scheduled in 45 minute blocks, to be paid cash or e-transfer at time of lesson. Cash payments are to be labelled and left in the orange bin. Etransfers are to be sent to jennyjelen55@gmail.com.
- Semi-private/group lessons may be available at \$50+HST, scheduled in 60 minute blocks, per rider. All semi-private and group lessons are subject to availability and the discretion of the Coach.
- All students must have a current waiver signed.
- Students may be invited to participate in "practise rides," subject to skills and availability. Practise rides are not supervised by the Coach. A horse rental fee of \$25+hst is charged per practise ride.
- Students are to arrive on time for their scheduled lesson. Riders who tack and prep their own horse independently are asked to be ready for scheduled time.
- Students are responsible for catching their horse from the field or stall, and grooming and tacking. Students capable of independently catching, grooming and tacking may be invited to arrive prior to their scheduled start time to prepare their horse. If students require assistance with catching, grooming and tacking, it will be included in their session. If you have questions, please ask your coach about what time to arrive.
- Lesson horses will be assigned prior to the student's arrival. The horse and rider combinations will be listed on the white board at the entrance of the barn.
- Riders are responsible for cooling out, untacking and grooming their horse, and returning it to its field/stall after their ride. If students require assistance with grooming and untacking, it will be included in their session.
- Riders are responsible for putting their tack away in its proper place, rinsing off their horse's bit, and returning all grooming tools to their original place. Failure to do so could result in an unmounted lesson on tack cleaning, care of equipment, or stable management, at the discretion of the Coach.
- Riders are also responsible for sweeping up hoof pickings, manure, or any other mess created by their horse from the aisle, arena or yard, that occurred while they were riding or preparing to ride. Failure to do so may result in an unmounted lesson on equine facility management, at the discretion of the Coach. If riders are repeatedly asked to clean up after their horse/pony, they may be subject to a \$10+HST fee per mess left behind.

- In case of extreme weather, that could result in a dangerous riding environment, the Coach reserves the right to cancel the lesson, or teach a groundwork/unmounted lesson.
- Lessons cancelled within 24 hours are subject to full payment, to be paid prior to scheduling the next lesson. We work to ensure our horses and staff are scheduled appropriately, to ensure you are best matched to a suitable mount. Please help us keep the schedule running most efficiently by arriving on time and rescheduling lessons in advance.
